The Arunachal Pradesh Public Service Commission invites online application from citizens of India for filling up 413 (Four hundred thirteen) posts of Junior Engineer through Common Recruitment Examination under various works Departments of Govt. of Arunachal Pradesh in the Pay Matrix Level-6 (₹ 35400-112400/-) Group B (Non-Gazetted) Non-Ministerial as admissible under the rule.

(1) The number of vacancies and the reservation for APST and PwBD candidates mentioned above are as per "Proforma Requisition" submitted by the Indenting /Requisitioning departments of Govt. of Arunachal Pradesh.

(2) Applicants can indicate the preference of department in the application form. Preference of department once submitted shall be deemed final and under no circumstance will the candidates be

allowed to change their order of preference at later stage. The merit list of the candidate shall be determined as per order of preference indicated by the candidate for particular department (s).

(A) HOW TO APPLY

- (1) Before filling the Online Application Form for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.
- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on <https://appsc.gov.in>. Detailed instructions for One Time Registration (OTR) and Online Application are available on the APPSC website (<https://appsc.gov.in>).
- (4) Applicants in Government Service have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.
- (5) The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (6) The online application submission link shall be active from 1700 hours on **18.09.2025 (Thursday)** till last date of submission i.e. before 1700 hours on **10.10.2025 (Friday)** on the APPSC website.
- (7) The candidates should carefully fill the requisite details in the online application form. Their admission at all stages of examination i.e. Written Examination and Viva-voce will be purely provisional. Any information found to be wrong at any time before or after any stage of examination may lead to cancellation of candidature for Junior Engineer Common Recruitment Examination-2025.

(B) ELIGIBILITY

- (1) Minimum 3 (three) years Diploma/Bachelor's Degree or Bachelor of Technology or equivalent from a recognized Institutions/University in the subject mentioned against each posts.

(2) Candidate, who have appeared or are appearing in the final year/semester examination of the qualifying degree are also eligible to apply. However, their candidature will finally be accepted on production of proof of having passed the qualifying examination in original on or before the date of interview so fixed by the Commission failing which they will not be allowed to appear in the Interview/Viva-voce.

(C) AGE LIMIT

(1) Not less than **18** years and not exceeding **35** years of age as on **10/10/2025**. However, the upper age limit is relaxable in accordance with orders issued by the Govt. of Arunachal Pradesh from time to time.

(2) Age concession in respect of candidates belonging to PwBD and regular Government servant of Government of Arunachal Pradesh will be as per Govt. rules and guidelines in force from time to time.

(D) METHOD OF SELECTION

(1) The eligible candidates will have to appear in written examination notified by the Department of Administrative Reforms, Government of Arunachal Pradesh vide notification no. AR-101011/5/2025-SECT-1-AR dated 9th April, 2025 in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission.:

(1) The candidate should note that there will be penalty negative marking of 1/6 for each wrong answer marked by a candidate.

(2) The number of candidates to be invited for Interview/Viva-voce shall be about three (03) times the number of advertised vacancies (category/ post as applicable) depending on the availability of qualified

candidates or as decided accordingly by the Commission subject to securing minimum qualifying marks.

(3) In order to qualify for viva-voce/interview, the candidate should score an aggregate of 33% of the total marks in both the papers, subject to the condition that the candidate should score at least 20% in each of the subjects.

(4) In order to qualify a PwBD category candidate for viva-voce/interview, the candidate should score an aggregate of 20% of the total marks in both the papers, subject to the condition that the candidate should score at least 10% in each of the subjects.

(E) EXAMINATION DATE

(1) The Junior Engineer Common Recruitment Examination-2025 is tentatively scheduled on **11.01.2026 (Sunday)**.

(F) EXAMINATION CENTRES

(1) The Junior Engineer Common Examination- 2025 will be conducted at the following centres:-

Note: The APPSC reserves the right to allocate or change the examination centres, if required at its discretion. No request for change shall be entertained from the candidates by the APPSC.

(G) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED

- (1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- (2) Latest/Recent colour passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Diploma/Degree/Master Degree certificates, if any and Mark Sheets (from 1st year to 3rd year for Diploma holders and from 1st year to 4th year for Degree holders) issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University.
- (4) Self-Attested photocopy of Matriculation Certificate for proof of age issued by recognized Board only will be accepted. No other documents relating to age like horoscope, affidavits, birth extract from Municipal Corporation, registrar of economics and statistics and service records shall be accepted.
- (5) Self-Attested Photocopy of APST certificate (to avail reservation under APST reservation category) and copy of PRC/Aadhar Card in case of General candidates.
- (6) Person with Benchmark Disability (PwBD) candidates should submit disability certificate issued by the certifying authority as per Section 57 of Rights of Persons with Disabilities Act, 2016, failing which, such candidates shall not claim the reservation under PwBD category and shall not be entitled for any concession. In the Medical Board, the Speciality of the particular disabilities, for which certificate is sought, must be a member. Otherwise, the Disability Certificate will not be accepted.
- (7) Person with Benchmark Disability (PwBD) candidates in the category of Blindness, Locomotor Disability (Both arms affected - BA) and Cerebral Palsy will be allowed compensatory time of 20 mins per hour of the examination on submission of Appendix-I. In case of other categories of Person

with Benchmark Disability (PwBD), this facility will be provided on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care Institution. Format of Appendix-I is available for download in the APPSC website.

(H) FACILITY OF A SCRIBE

- (1) Only Person with Benchmark Disability (PwBD) in the category of Blindness, Locomotor Disability (Both arms affected - BA) and Cerebral Palsy will be permitted the facility of scribe, if so desired by the person on submission of Appendix-I and Appendix-II. Format of Appendix-I and Appendix-II are available for download in the APPSC website.
- (2) In case of other categories of Persons with Benchmark Disability (PwBD), as defined under Section 2(r) of the RPwD Act, 2016, the facility of scribe will be allowed to such candidates on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care Institution.
- (3) Such candidates have discretion of opting for his/her own scribe or request the Commission for the same. The details of scribe i.e. whether own or the Commission's and the details of scribe in case candidates are bringing their own scribe, will be sought at the time of filling up the application form online. The qualification of the Commission's scribe or own scribe will not be more than the minimum qualification criteria of the examination. However, the qualification of the scribe should always be matriculate or above.

(I) APPLICATION FEE

- (1) APST candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidates and ₹ 200/- (Rupees Two Hundred) only for other candidates through online mode only.
- (2) PwBD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.

(J) LAST DATE FOR SUBMISSION OF APPLICATION: 10.10.2025 (Friday) (1700 Hours).

(K) ON THE DAY OF THE INTERVIEW/VIVA-VOCE:

Selected candidates for the Interview/Viva-Voce will have to produce the above-mentioned (at Point G) Certificates/Documents and Mark Sheets in **original** at the time of interview, failing which he/she will not be allowed to appear in the interview.

NOTE:

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to Recruitment test/Interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (2) The Selection will be provisional subject to verification of requisite documents/qualifications by the Indenting Department.
- (3) In case of PwBD candidates, the selection process will be as per the Rights of Persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
