Online applications are invited from the prospective candidates for recruitment to Civil Judges (Junior Division) in Odisha Judicial Service through Proforma Application to be made available on the WEBSITE of the Commission (<https://opsc.gov.in>). The link for registration and payment of examination fee shall be available from **08/05/2026 to 08/06/2026 (5.00 P.M.) (Note- 08/06/2026 (5.00 P.M.) is the last date / closing date for submission of registered Online Application)** for recruitment to **78 (Seventy Eight)** posts of Civil Judges (Junior Division) in Odisha Judicial Service, 2025 under Law Department by direct recruitment in the pay scale of Rs.77,840-1,36,520/- with usual dearness and other allowances as may be sanctioned by the Government of Odisha from time to time.

**2. VACANCY POSITION:** As per requisition furnished by the Law Department, Government of Odisha, **the vacancy position for the post of Odisha Judicial Services, 2025 is 78(26-w)**. Out of which 35(12-W) vacancies are for UR category, 09(03-W) vacancies are reserved for SEBC, 13(04-W) vacancies are reserved for SC category, 18(06-W) vacancies are reserved for ST category and 03(01-W) vacancies are reserved for Persons with Benchmark Disabilities.

**3. AGE:** A candidate must be not below **23 (Twenty three)** years of age and not above **42 (Forty two)** years of age as on the **1<sup>st</sup> day of the month of April, 2025** and he/she must not have been born earlier than the **2nd April 1983** and not later than the **1st April 2002**.

**4. EDUCATIONAL QUALIFICATION:** A graduate in law of a recognized University or institutions recognized by the Government and having at least three years of practice as an advocate on **1<sup>st</sup> April, 2025**.

Provided that the period of experience as a Law Clerk/Research Assistant to any Judge or Judicial Officer in the Country, or to any Constitutional Authority shall be counted towards the period of legal practice.

**5. EXAMINATION FEE:** The candidates other than SC, ST and PwD category shall have to pay the examination fee amounting to **Rupees Seven Hundred (₹700/-) only** through online mode while filling the Online Application Form. The examination fees paid shall be **refunded only to those candidates who actually appear in the Preliminary Written Examination. Applications without payment of examination fees (except SC/ ST/ PwD candidates) will be taken as incomplete and outrightly be rejected.**

Refund shall be issued in due course after completion of the Written Examination. Refunds will be processed to the original mode of payment used at the time of the transaction by the candidate. (Credit Card, Debit Card, UPI, Net Banking, Wallet, etc.)

**6. METHOD OF SELECTION:** The selection of candidates for recruitment to the cadre of Civil Judges (Junior Division) shall be made through competitive examination, which shall consist of three parts; viz- Preliminary Written Examination, Main Written Examination and Interview as per the provisions of the Odisha Superior Judicial Service & Odisha Judicial Service Rules, 2007 (as amended from time to time).

The recruitment is to be conducted according to the provisions mentioned in the Orissa Superior Judicial Service and Orissa Judicial Service Rules, 2007, as amended from time to time.

**NOTE-1:**

(a) From out of the vacancies reserved for each of the categories and for the un-reserved categories, to the extent of four percentum of the vacancies shall be reserved horizontally for Persons with Benchmark Disabilities having not less than 40% Permanent physical disability as specified in the Schedule to the Rights of Persons with Disabilities Act, 2016 (49 of 2016) excluding cerebral palsy.

Provided that in case of non-availability of suitable Persons with Benchmark Disability or for any other sufficient reasons, such vacancy shall be carried forward to the subsequent recruitment year and if in the subsequent recruitment year also suitable Persons with Benchmark Disability is not available, it may first be filled by interchange among the five categories and only when there is no Person with Disability available for the post of that year, such vacancy shall be filled other than a Person with Disability.

(b) In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the vacancies or, as the case may be, the remaining vacancies shall be filled up by eligible male candidate(s) of that category.

(c) In case of non-availability or availability of insufficient number of candidates of any reserved category of S.C., S.T. and S.E.B.C., the vacancies shall be filled up by the candidates of the un-reserved category as per Rule-17(3) of the O. S. J.S & O.J.S. Rules, 2007.

**NOTE-2:**

(a) The candidates applying against SEBC Category (Non-Creamy Layer) must submit Caste Certificate issued by the Competent Authority not more than 03 years before the date of submission of Online Application Form. Candidates furnishing SEBC certificate which is issued more than 03 years prior to the date of submission of Online Application, shall not be considered under SEBC category.

(b) PwD Candidates must upload their Permanent Disability Certificate. Certificate showing Temporary Disability will not be accepted and the application shall be liable for rejection.

(c) According to the Odisha Ex-Servicemen (Recruitment to State Civil Services and Posts) Amendment Rules, 2021 issued vide General Administration and Public Grievance Department Notification No. 15318/Gen., dt. 09.06.2021, those Ex-Servicemen who have already secured regular employment under the State Government in civil posts and services shall not be eligible for benefit of reservation if any, for Ex-Servicemen in the State Government, but they would be permitted the benefit of age relaxation as admissible for Ex-Servicemen for securing another employment in any higher post or service under the State Government.

(d) Experience has shown that, some candidates obtain SC/ST/SEBC certificate etc. immediately ahead of the date of Application and upload the same along with Online Application, only to secure admission to the examination, which sometimes get cancelled subsequently on the grounds of inadmissibility etc. If any such cancellation of any uploaded certificate is detected at any stage of the recruitment examination or even subsequently, the candidature of such candidates will be cancelled or recommendation be withdrawn as the case may be if the candidate has availed the benefits of Reservation.

(e) The number of vacancies to be filled up on the basis of this recruitment is subject to change by the Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

### **3. AGE:**

A candidate must be not below **23 (Twenty three)** years of age and not above **42 (Forty two)** years of age as on the **1<sup>st</sup> day of the month of April, 2025** and he/she must not have been born earlier than the **2nd April 1983** and not later than the **1st April 2002**.

Provided that, the upper age limit shall be relaxed by five years for candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Socially and Educationally Backward Classes (SEBC), Women, Ex-servicemen and Commissioned / Short Service Commission Officers of the Defense Services and by ten years for Persons with Benchmark Disabilities (PwBDs) as referred to in sub-rule (5) of Rule- 17, in addition to the normal age relaxation admissible to Scheduled Caste, Scheduled Tribe and SEBC category candidates.

The upper age limit shall be relaxed by seven years for candidates having Service experience as a Law Clerk/Research Assistant to any Judge or Judicial Officer in the Country, or to any Constitutional Authority.

Provided that a candidate who comes under more than one category mentioned above, he/she shall be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him/her.

(SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED).

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

### **4. EDUCATIONAL QUALIFICATION AND EXPERIENCE:**

A candidate must be a graduate in Law of a recognized University or Institutions recognized by the Government and having at least 03 years of practice as an advocate on 1<sup>st</sup> April 2025.

Provided that, the period of experience as a Law Clerk/Research Assistant to any Judge or Judicial Officer in the Country, or to any Constitutional Authority shall be counted towards the period of legal practice.

**N.B. :** A candidate of the above category should furnish with his/her application necessary evidence to the effect that his/her case has been recommended by the competent authority and that he or she satisfies the aforesaid conditions of eligibility.

## **5. EXAMINATION FEE:**

As per Odisha payment of recruitment examination fees and Refund Rules, 2025 published vide Government in G.A. & P.G. Department Notification No. 34124-GAD-SC-rules-0020/2025/Gen. dated 10.10.2025, the candidates other than SC, ST and PwD category shall have to pay the Examination fees.

The candidates other than SC, ST and PwD category shall have to pay the examination fee amounting to **Rupees Seven Hundred (₹700/-) only** through online mode while filling the Online Application Form. The examination fees paid shall **be refunded only to those candidates who actually appear in the Preliminary Written Examination. Applications without payment of examination fees (except SC/ ST/ PwD candidates) will be taken as incomplete and outrightly be rejected.**

Refund shall be issued in due course after completion of the Written Examination. Refunds will be processed to the original mode of payment used at the time of the transaction by the candidate. (Credit Card, Debit Card, UPI, Net Banking, Wallet etc.) However, the candidates shall have to furnish their bank account details i.e. Account Number, IFSC Code, Name of the Account Holder and Name of the Bank branch in the required field in the Online Application Form which will be required in case of failure of refund of money through the original mode of payment owing to technical glitches or other issues, if any. The Bank Account must remain valid/active. The onus of furnishing the correct bank account details lies with the candidates and the Commission (OPSC) shall not entertain any correspondence from any candidate in this regard.

## **6. PLAN OF EXAMINATION:**

The selection of candidates for recruitment to the cadre of Civil Judges (Junior Division) shall be made through competitive examination, which shall consist of three parts; viz- Preliminary Written Examination, Main Written Examination and Interview as per the provisions of the Odisha Superior Judicial Service & Odisha Judicial Service Rules, 2007 (as amended from time to time) and the syllabus as specified below:-

### **A. Preliminary Written Examination :**

**(I)** The Preliminary written examination shall be of one paper carrying 100 marks with duration of one and half hours of examination with objective type questions of multiple choice **100 questions of one mark each with negative marks of twenty-five percent for every wrong answer allotted to that particular question** on the following subjects and the OMR answer sheets will be scrutinized by Computer.

- (a) The Constitution of India
- (b) The Code of Civil Procedure, 1908
- (c) The Code of Criminal Procedure, 1973 and The Bharatiya Nagarik Suraksha Sanhita, 2023
- (d) The Indian Evidence Act, 1872 and The Bharatiya Sakshya Adhiniyam, 2023
- (e) The Indian Penal Code, 1860 and The Bharatiya Nyaya Sanhita, 2023
- (f) The Limitation Act
- (g) The Transfer of Property Act

- (h) The Law of Contract
- (i) The Law of Succession (Indian Succession Act and Hindu Succession Act)
- (j) The Specific Relief Act
- (k) The Protection of Women from Domestic Violence Act, 2005, and any other relevant topics in law(s), as the High Court of Orissa may specify from time to time.

**N.B.:** - The Commission shall call the eligible candidates for Main Written Examination, who have secured not less than **35 (thirty-five) per centum of marks** in case of Scheduled Caste and Scheduled Tribe candidates and Persons with Benchmark Disabilities and **40 (forty) per centum of marks** in case of others in the Preliminary Written Examination.

**B. Main Written Examination:**

**(II)** The main written examination shall be on the following two compulsory papers and three optional papers. Each of the compulsory subjects shall carry 150 marks with a duration of **2 ½ (two and half) hours** of examination and each of the optional subjects shall carry 150 marks with a duration of **three hours**.

**NOTE-1:**

- (a) A candidate shall answer the papers in English unless otherwise directed.
- (b) The standard of papers shall be that of L.L.B. Course and in respect of Compulsory Paper-I, it shall be of a degree course.
- (c) The Commission shall call the candidates, from amongst those who have secured not less than **45 (forty-five) per centum of marks** in aggregate and a minimum of **33 (thirty three) per centum of marks** in each paper in the Main Written Examination, for interview which shall not more than three times the number of advertised vacancy under each category in order of merit.

Provided that candidates with Benchmark Disabilities who have secured not less than **thirty per cent marks** in each paper and a minimum of **forty per cent marks** in aggregate shall be eligible to be called for the interview in proportion of 1:5.

**NOTE-2:**

The optional subjects for the Main Written Examination, mentioned by the candidate in the online application form, will be treated as final. **No request for change of optional subject(s) will be entertained.**

**C. INTERVIEW: -**

(III) Interview shall carry 100 (one hundred) marks. Questions to be asked in the Interview may not ordinarily be outside the syllabus prescribed for the Main Written Examination. In the Interview, questions covering broad national and International issues and matters of common interest in the field of Arts and Science may also be asked.

**NOTE-3:**

The marks secured by the candidates in the Interview shall be added to the marks obtained in the Main Written Examination so as to arrive at the total marks secured by the candidates and the names of the candidates shall be arranged in order of merit on the basis of such total marks.

Provided that the names of the candidates shall not be included in the merit list unless such candidates secure a minimum of **forty per centum (40%) marks** in the interview.

The Documents / Testimonials submitted by the candidates will be verified before the Interview with respect to their correctness and authenticity.

The Commission shall prepare a list of candidates in order of merit on the basis of Main Written Examination and Interview, which shall be equal to the number of advertised vacancies;

Provided that, if two or more candidates secure equal marks in the aggregate the order shall be determined in accordance with the marks secured at the Main Written Examination and if the marks secured at the Main Written Examination of the candidates concerned be also equal, then the order shall be decided in accordance with the total marks obtained by them in the LLB Examination and if the marks obtained in the LLB Examination are also equal, the candidate who is older in age shall be placed above the other (younger).

The list recommended by the Commission shall remain valid for a period of one (01) year from the date of its approval by the Government.

**NOTE-4:** Any details relating to this recruitment like cut-off marks, answer keys, individual marks etc. shall only be declared on the website of the Commission after publication of the final result and select list.

**7. DATE OF EXAMINATION:**

The **Preliminary Examination** will be held on **5<sup>th</sup> July, 2026 (Sunday)**. The detailed schedule and Centres of the Preliminary Written Examination of OJS-2025 will be notified in due course.

**N.B.:** After completion of the Preliminary Written Examination, the Provisional Answer Key of the Paper shall be uploaded in the Website within 10 days of the examination. Inviting suggestions/objections, if any, from the candidates. Those candidates who do not challenge the Provisional Answer key shall forfeit their right to agitate the matter subsequently in any forum in any other manner.

**8. PLACE OF EXAMINATION:**

- a. The Preliminary Written Examination will be held at Six (06) Zonal Centres of the state, viz; Balasore, Berhampur, Bhubaneswar, Cuttack, Jeypore and Sambalpur depending on the number of candidates on the respective zones in case sufficient number of candidates are not available for any of the zones of Balasore, Berhampur, Jeypore and Sambalpur, the candidates opting for those zones will be accommodated at Bhubaneswar and Cuttack. Candidates are **required to select any 02 zones of their choice** where they would like to appear at the Examination, during filling of Online Application form. While every effort will be made to allot candidates to the zones of their choice **on First Come First Serve basis**, the Commission may, at their discretion, allot any other zone to the candidates when circumstances show warrant. **REQUEST FOR CHANGE OF ZONE WILL NOT BE ENTERTAINED**. The candidates are not allowed to appear at a centre other than the one indicated by the Commission.
- b. The Main Written Examination may be held either at the above 06 zones or at Bhubaneswar and Cuttack zones only taking into view the number of candidates selected for the said examination.

## 9. **OTHER ELIGIBILITY CONDITIONS:**

- i. The candidate must be a citizen of India;
- ii. He/She must be of good character and of sound health and free from any organic defect and physical infirmity.
- iii. He/She must be able to speak, read and write Odia fluently and must have passed an examination in Odia language equivalent to that of Middle English School standard (i.e. Class/Standard-VII) within the last date;
- iv. A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- v. Government servants, whether temporary or permanent, are eligible to apply provided that, they possess the requisite qualification and are within the Prescribed age-limit as provided under Para-3 & Para-4 of the Advertisement respectively. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification. So, the candidates must obtain NOC well in advance;

The Government Servants as enumerated in Para-4 who offer their candidature for the examination should submit their applications through the Appointing Authority. Candidates should note that in case a communication is received from their employer by the Commission withholding permission to the candidates applying for/appearing at the examination, their applications will be liable to be rejected/ candidature will be liable to be cancelled;

- vi. If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or other State Public Service Commission or U.P.S.C. from appearing at any examination / viva voce test, he/she **will not be eligible** to apply for that specified period / chance(s);
- vii. **Only those candidates, who possess the requisite qualifications, are within the prescribed age limit and fulfill other eligibility conditions strictly etc. by the closing date for submission of registered online application form, will be considered eligible;**
- viii. Every candidate selected for appointment shall be examined by the Medical Board and any candidate who fails to qualify the Medical Board shall not be eligible for appointment.
- ix. The period of probation will be applicable as prescribed in the recruitment rules.
- x. A candidate who claims change in his/her name after having passed the H.S.C. examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his/her change of name;

**10. IMPORTANT POINTS:**

- (i) The provisions of the Odisha Conduct of Examinations Act, 1988 (Odisha Act-2 of 1988) are applicable to this Examination (Preliminary & Main) conducted by the Odisha Public Service Commission. Any violation of the above Act and violation of **"Instructions to candidates"** (as provided in the advertisement, application form, Brochure, Admission Certificate & Answer Script etc.) will be seriously viewed and disciplinary action will be taken against the concerned candidates as deemed proper.

(b) While filling up the marks in the relevant box of the online application form, the candidate has to mention the actual marks secured (**excepting marks secured in the Extra Optional/4<sup>th</sup> Optional Subject**) in each semester/examination passed (i.e. H.S.C. to Bachelor's Degree of Law).

- (ix) Persons with Benchmark Disabilities are required to submit/upload Permanent Disability Certificate (indicating percentage of **permanent disability** i.e. 40% or more) issued by the concerned Medical Board wherever applicable;
- (x) Certificate of good character from the Principal/Proctor/Dean or Professor in charge of the department of teaching of the College or University/Institution in which last studied;
- (xi) Four recent passport size photographs (within 06 months) **unsigned & unattested**, which has been uploaded with online application form;
- (xii) No Objection Certificate from their competent authorities in case of Government Servants.
- (xiii) Any proof of identity;
- (xiv) **The Third Gender / Transgender candidates shall upload their Identity Certificate/Card issued by the Competent Authority as well as requisite document in support of change of their name on getting the Third Gender/ Transgender Status, if any.**
