NOTICE

Subject: - Declaration of marks of online examination (Tier-I) held on 22.02.2026 & 23.02.2026 for the post of Junior Engineer (Electrical/Mechanical), Post Code – 44/25 in Delhi Jal Board & shortlisting of candidates for Tier-II examination - regarding.

1. The DSSSB vide advertisement No. 02/25 dated 31.07.2025 had advertised **50 vacancies (UR-34, EWS-NIL, OBC-01, SC-11 ST-04 including PwBD- 02 {01 (c) category, 01 (d&e)})** for the post of **Junior Engineer (Electrical/Mechanical)** in Delhi Jal Board under Post Code – 44/25. The online examination was held on **22.02.2026 & 23.02.2026**.
2. The marks obtained by **2382 candidates** who duly appeared in written examination (Tier-I) conducted (online mode) on **22.02.2026 & 23.02.2026** for the Post of **Junior Engineer (Electrical/mechanical), Post Code – 44/25** in Delhi Jal Board have been uploaded on the OARS module of the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
3. As per Advertisement No. 02/25, the examination scheme for post code – 44/25 is Tier-I (Technical) (MCQ) examination conducted by the DSSSB on 22.02.2026 & 23.02.2026.
4. Accordingly, based on the performance in the Tier-I written examination, **596 Candidates (UR-340, EWS-NIL, OBC-45, SC-150, ST-58, PwBD (c) category- 01, PwBD (d&e) category- 02)** in the merit have been provisionally shortlisted for appearing in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be informed separately for Tier-II examination.
5. The cutoff marks of shortlisted candidates for appearing in Tier-II examination is as under:-

6. Only those candidates have been considered in OBC category who have declared that they are OBC (Delhi) in their Online Application Forms.

7. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

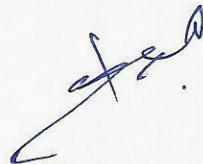

Reserved category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted in UR Category and their selection to the post shall be considered in UR Category subject to Merit and availability of vacancies, otherwise in their respective Category subject to Merit and availability of vacancies.

9. The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Tier-II examination by the Board. The candidates are advised to check the website of DSSSB regularly.

8. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify error and omissions if any, detected at any stage.

9. The above shortlisting candidates for Tier-II examination for the post of Junior Engineer (Electrical/Mechanical) **under post code – 44/25 in Delhi Jal Board** is subject to outcome of pending court case, if any.
