Performance dimensions are broader and deeper than what a person must now and be able to do in order to function well in his or her job. They include attitude, values and character traits. They exist at various levels of human personality. At the behavioral level, we can observe skills and knowledge. Social roles and self image dimensions are found at the intermediate level. Motives and traits exist at the inner most or core level. If we can identify those performance dimensions which are most highly correlated with job success, we can put them together to form a blue print for outstanding performance in both thought and action.

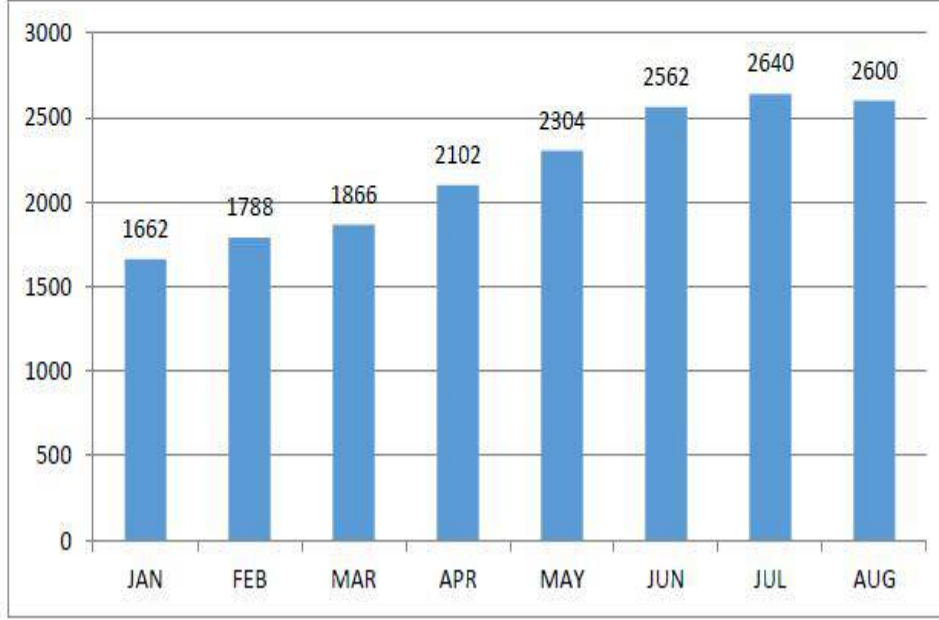
