ISRO's Successfully Lift Off Anomaly in PS3 Stage of PSLV-C62/EOS-N1 Mission

India's PSLV-C62 rocket carrying the EOS-N1 satellite encountered an anomaly during the final phase of its third stage on January 12, 2026. The launch took place from Sriharikota after a 22.5 hour countdown. While initial stages performed normally, deviations in roll rate and flight path were observed, prompting ISRO to begin a detailed technical analysis.

Why in News?

The PSLV-C62/EOS-N1 mission faced a technical anomaly near the end of the PS3 stage. ISRO confirmed that the issue led to deviations in the rocket's trajectory, and further assessment of mission data is in progress.

Mission Overview and Launch Details

The PSLV-C62/EOS-N1 mission followed a 22.5-hour countdown before lifting off from Sriharikota, marking the 105th launch from the spaceport and the 64th flight of the PSLV. The mission used the PSLV-DL variant, which features two strap-on boosters, and was the fifth flight of this configuration.

EOS-N1, an Earth observation satellite built for strategic applications, was the primary payload. The launch was a commercial mission executed by NewSpace India Limited (NSIL), ISRO's commercial arm. Alongside EOS-N1, 15 co-passenger satellites developed by startups and academic institutions from India and abroad were onboard, reflecting India's growing role in the global small satellite launch market.

Planned Mission Profile

Under the original mission plan, EOS-N1 and 14 of the co-passenger satellites were to be injected into a Sun Synchronous Orbit (SSO). The remaining payload, the KID capsule developed by Orbital Paradigm (Spain) in collaboration with RIDE (France), was intended for a re-entry experiment.

Following satellite deployment, the PS4 stage was scheduled to restart to de-boost itself and enter a re-entry trajectory. Both the PS4 stage and the KID capsule were expected to re-enter Earth's atmosphere and impact the South Pacific Ocean. ISRO has not yet confirmed whether these objectives were achieved.

What Did ISRO Say About the Anomaly?

ISRO Chairman V Narayanan stated that a deviation was noticed during the third stage of the rocket. He clarified that mission data is currently being analysed and that ISRO will share detailed findings soon. At present, the mission has not been officially declared a success or failure.

Key Payloads and Strategic Importance

One of the major satellites onboard was Anvesha, a surveillance satellite developed by the Defence Research and Development Organization. Anvesha is designed to provide advanced imaging capabilities, enhancing India's ability to monitor and map strategic locations with high precision, which is vital for national security and disaster management.

Role of the Private Space Sector

The mission marked a milestone for India's private space ecosystem. For the first time, a single private company, Dhruva Space from Hyderabad, contributed seven satellites to a PSLV mission. This highlights the growing collaboration between ISRO and private players following space sector reforms.

WEF Global Risks Report 2026

The **World Economic Forum (WEF) Global Risks Report 2026 (21st edition)** paints a worrying picture of the coming decade. The report suggests that the world is moving into an **"Age of Competition"**, where rivalry between countries is intensifying—not only in the military space, but also through **trade restrictions, sanctions, technology controls, and information warfare**. This shift is creating a global environment where shocks spread faster, cooperation becomes harder, and societies become more vulnerable to instability.

The report ranks risks across **two key time horizons**—the near future (2 years) and the long term (10 years). Its core message is straightforward: the global landscape is becoming **more fragmented, more unpredictable, and more exposed to multiple overlapping risks**.

1) What Does WEF Mean by "Global Risk"?

WEF defines a **global risk** as a threat or event that can cause major negative impact on a large scale, affecting:

- the world's population
- the global economy
- natural resources and ecological systems

This definition matters because it places emphasis on threats that cross borders, spread rapidly, and create ripple effects across regions.

2) How the Report Is Built

The report is primarily based on expert perceptions collected through global surveys of leaders and specialists across sectors. It then organizes risks into categories such as:

- **Geopolitical**
- **Economic**
- **Societal**
- **Technological**
- **Environmental**

It also studies how risks connect with each other, showing that crises rarely happen in isolation. Instead, one major event often triggers several others.

3) Global Mood: Instability Is Rising

A major finding of the report is that a large share of experts expects the world to experience **turbulence** in both the short and long term. This suggests that many see current tensions as part of deeper structural changes rather than temporary fluctuations.

Main reasons behind the growing instability include:

- rising rivalry between major powers
- shrinking space for international cooperation
- economic pressures such as high debt and uneven growth
- rapid technological disruptions
- intensifying climate impacts

4) Most Likely Crisis Trigger in 2026: Geoeconomic Confrontation

The report identifies **geoeconomic confrontation** as the most likely risk to trigger a global crisis in 2026.

What geoeconomic confrontation means

It refers to the use of economic tools as instruments of strategic power, such as:

- sanctions and counter-sanctions
- tariffs and trade barriers
- restrictions on technology exports
- control over supply chains
- manipulation of critical resources (oil, gas, rare earth minerals, chips)

Why it is dangerous

Geoeconomic rivalry:

- disrupts global trade networks
- increases inflationary pressures
- reduces investment confidence
- weakens global supply chains
- creates uncertainty for industries and jobs

In today's world, economic rivalry is becoming as destabilizing as direct military confrontation.

5) Conflict and Security: The Risk of Armed Escalation

Along with economic rivalry, the report highlights **state-based armed conflict** as a leading risk. Conflicts today have grown more complex because they often combine:

- conventional warfare
- cyberattacks
- economic sanctions
- information manipulation

Key concerns linked to armed conflict

- damage to infrastructure and energy networks
- global commodity price instability
- increase in displacement and migration
- rising military expenditure at the cost of development spending

6) Information Crisis: Misinformation, Disinformation, and Polarization

One of the strongest warnings in the report is the growing influence of **misinformation and disinformation**, especially through digital platforms. The report links false information with **social unrest and political division**.

How misinformation becomes a global threat

- spreads confusion during crises (pandemics, wars, disasters)
- reduces trust in governments and media
- creates fear and anger among communities
- influences elections and public decision-making

Societal polarization: a connected risk

Polarization means deep social division where people move into rigid groups and stop trusting each other.

The long-term risk ranking is dominated by environmental dangers. The report highlights that climate risks are not only continuing but intensifying.

Top environmental risks (long-term)

- extreme weather events
- biodiversity loss and ecosystem collapse
- critical changes to Earth systems
- pollution
- resource shortages (water, food, minerals)

Why this is alarming

Environmental damage creates chain reactions:

- crop failures and food insecurity
- water stress and conflicts
- forced displacement
- economic shocks
- increased health emergencies

The report warns that climate stress can become a multiplier—making economic and political risks even worse.

11) Inequality: The Most Interconnected Global Risk

Henley Passport Index 2026

The **Henley Passport Index 2026** once again highlights the sharp divide in global travel freedom, ranking passports based on how many destinations their holders can visit without needing a visa in advance. India's global travel access has seen a modest improvement in 2026. According to the latest passport rankings, Indian travellers can now visit more countries without lengthy visa procedures than last year. However, significant limitations remain for popular destinations like Europe and North America, shaping how Indians plan international trips.

Why in the News?

The Henley Passport Index 2026 has ranked **India at 80th position globally**. Indian passport holders get visa free, visa-on-arrival or e-visa access to 55 destinations, up from last year's rank of 85.

India's Rank in the Henley Passport Index 2026

- India is ranked 80th in the Henley Passport Index 2026. Indian passport holders currently enjoy visa-free or visa-on-arrival access to 55 destinations.
- India shares this position with Nigeria and Algeria, while regional neighbours Bangladesh and Pakistan rank even lower.
- The data reflects a significant mobility gap within South Asia and between India and leading global economies.

World's Most Powerful Passports in 2026

- At the top of the rankings, Singapore holds the number one position, with its citizens enjoying visa-free or visa-on-arrival access to 192 destinations, the highest in the world.
- Japan and South Korea jointly occupy the second position with access to 188 destinations, reflecting their strong diplomatic networks and stable international relations.
- Europe continues to dominate the upper ranks, with multiple EU countries offering access to over 185 destinations, highlighting the strength of European diplomacy and integration.

Which Country Has the Weakest Passport in the World?

- Afghanistan (Rank 101) – 24 destinations
- Afghanistan holds the weakest passport globally, allowing access to just 24 destinations without a prior visa.
- It is followed closely by Syria and Iraq, underscoring how conflict, political instability, and security concerns sharply limit international mobility.
- The gap between the most powerful passport (Singapore) and the weakest (Afghanistan) now stands at 168 destinations.

Gol Approves Wage Revision and Pension Revision for PSGICs, NABARD and RBI

The Central Government has approved **wage revision** and **pension revision** for employees and pensioners in key financial institutions, including **Public Sector General Insurance Companies (PSGICs), NABARD, and Reserve Bank of India (RBI)**. This move is being seen as a significant step towards boosting employee morale, ensuring improved retirement security, and strengthening social welfare measures in the financial sector. The decision highlights the Government's continued focus on **social security, fair compensation**, and the **financial well-being of pensioners**, especially those who have dedicated decades of service to India's economic and financial institutions.

What Has Been Approved?

The announcement covers three major areas:

- Wage revision for employees of PSGICs**
- Pay revision for employees of NABARD**
- Pension revision for retirees of RBI and NABARD**
- Family pension revision for PSGICs**

This policy intervention is important not just for beneficiaries but also for government exam aspirants, as it touches multiple topics like **social security, financial sector reforms, public sector compensation**, and **retirement benefits**.

Wage Revision for PSGIC Employees (Effective from 1 August 2022)

- **Indian Army Launches Community Radio Station 'Radio Sangam' in Rajouri, J&K -** On January 2, 2026, the **Indian Army** in collaboration with civil administration launched "**Radio Sangam**", the **first community radio station** along the **Line of Control** at Keri village in **Rajouri, Jammu and Kashmir**, broadcasting on **88.8 FM**. **Radio Sangam** aims to provide **reliable information, promote local culture, and strengthen trust** between the Indian Army, civil administration, and villagers through **awareness campaigns, agriculture tips, cultural programs, and interactive shows**.

The event also launched **4 new initiatives** including **Guidelines for Recognition of In-House R&D Centres**, **PRISM Network Platform**, **Creative India 2025**, and **DSIR Disaster Management Plan** along with multiple **MoUs** for **technology transfer** and **skill development**.
- **ICAR-NDRI Developed Karan Fries Cattle Breed** - Through **Holstein Friesian-Tharparkar crossbreeding**, a new breed offering **high milk yield** in **hot-humid climates** was developed, improving dairy productivity in diverse Indian conditions.

INTERNATIONAL AFFAIRS

- **USA Withdraws from 66 International Bodies Including India-led ISA** - On January 7, 2026, USA President **Donald Trump** issued an executive order and presidential memorandum announcing **withdrawal from 66 international organizations, treaties, and commissions** including **India-and-France-led International Solar Alliance** and several **UN-affiliated entities**. The withdrawal covers **35 non-UN organizations** and **31 UN-affiliated bodies** including **IRENA, IPCC, IUCN, UNFCCC, UNFPA, and UN Water**, with USA formally exiting **ISA** ending approximately **USD 2.1 million contributions** made between 2022-2025 as part of "**America First**" review citing concerns over **national sovereignty** and resource use.
- **UNGA Declares 2026 as International Year for Rangelands and Pastoralists** - In January 2026, the **United Nations General Assembly** declared **2026 as the International Year of Rangelands and Pastoralists (IYRP)** at its 76th session, with resolution led by **Mongolia** and backed by **60 Member States** and **Food and Agriculture Organisation** as leading implementing agency. **IYRP 2026** aims to **share pastoralist knowledge, encourage innovation, build partnerships, and support policies** for sustainable rangelands and livelihoods, emphasizing that **rangelands covering 50% of Earth's land surface support over 2 billion people and 50% of world's livestock** while playing pivotal role in **biodiversity conservation** and **climate resilience**.
- **Archaeologists in Pakistan Discover 2,000-Year-Old Kushan Empire Coins** - Archaeologists in **Pakistan** have discovered **2,000-year-old Kushan Empire coins** and **lapis lazuli fragments** at **Bhir Mound near Taxila in Rawalpindi**. The coins belong to the era of **King Vasudeva**, one of the **last great Kushan rulers**. The discovery highlights the region's **ancient trade links, religious diversity, and historical importance** during the **early centuries of the Common Era**.
- **German Chancellor Friedrich Merz's First Asia Visit to India (January 12-13, 2026)** - German Chancellor Friedrich Merz is set to visit **India** on **January 12 and 13, 2026** at a crucial time for **India-Germany relations**, with both countries seeking **deeper cooperation in trade, technology, climate action, and global governance**. The visit includes **Sabarmati Ashram** and **India-Germany CEO Forum in Ahmedabad**, followed by **Bengaluru** featuring **IISc's CeNSE center** and **Bosch campus** showcasing **scientific research and sustainable mobility initiatives**, expected to further strengthen **strategic and economic engagement**.
- **India Launches e-B-4 Visa Category for Chinese Nationals** - **India** has launched a new **electronic business visa category** called the **e-B-4 Visa (e Production Investment Business Visa)** to **simplify and regulate business travel for Chinese nationals**, aiming to support **legitimate business activities** and respond to **rising demand for structured business engagement** between **India and China**.
- **India-China Bilateral Trade Crossed \$155.62 Billion in 2025** - **India-China bilateral trade** crossed **\$155.62 billion in 2025** despite recording a **record \$116.12 billion deficit**, reflecting significant **trade imbalance concerns** and highlighting the need for **balanced trade mechanisms** between the two economies.
- **China Commissions New Advanced Warship 'Loudi'** - **China** has recently strengthened its **naval power** by commissioning a new **advanced warship named Loudi**, highlighting how quickly the **Chinese Navy is expanding its fleet** in order to **match or challenge the naval strength of the United States**.
- **Italy Confers Order of the Star of Italy on Goa Industrialist** - **Italy** conferred the prestigious **Order of the Star of Italy** on **Goa industrialist Shrinivas Dempo** for **fostering India-Italy business and cultural ties**, recognizing his significant contributions to bilateral relations.
- **India and Germany Signed Joint Declaration on Telecommunications Cooperation** - In January 2026, **India and Germany** signed a **Joint Declaration on Telecommunications Cooperation** covering **policy, regulation, manufacturing, innovation, and global digital engagement**, strengthening **bilateral technological partnership** and digital collaboration.
- **Israel Announces Withdrawal from Seven UN Agencies** - **Israel** announces **withdrawal from seven UN agencies**, citing **alleged bias**, affecting **humanitarian and development programs** globally and raising concerns about international cooperation.
- **USA Freezes Immigrant Visa Processing for 75 Countries** - **USA** freezes immigrant visa processing for **75 countries** with implementation expected from **January 21, 2026**, impacting hundreds of thousands of visa applicants worldwide.
- **Yemen's PM Salem bin Breik Resigned** - **Yemen's PM Salem bin Breik** resigned, with **Foreign Minister Shaya Mohsen Zindani** appointed to **form new cabinet** amid ongoing political crisis in the country.
- **WEF Global Risks Report 2026 Flags Geoeconomic Confrontation as Top Threat** - The **World Economic Forum's Global Risks Report 2026** flags **geoeconomic confrontation** as the **top short-term threat** based on insights from **1,300+ expert views**, highlighting growing tensions in international economic relations.
- **Australian Universities Planning Bengaluru Campuses** - The **University of New South Wales (UNSW)**, **Australia** is planning a **Bengaluru campus** offering **undergraduate programmes in commerce, media, computer science, and data science**, along with **postgraduate programmes in cybersecurity**. The **University of Liverpool** and **Lancaster University** are also planning **Bengaluru campuses** to **expand access to international higher education in India**.

- **Australia's Finke River Recognised as World's Oldest Flowing River** - Australia's Finke (Larapinta) River, aged **300–400 million years**, is recognised as the **world's oldest flowing river**. Its path through the **MacDonnell Ranges** confirms it **predates the mountain formation**, making it a geological marvel.
- **Nobel Institute Clarifies Maria Corina Machado Cannot Transfer Prize Medal** - Although **Maria Corina Machado** symbolically handed her **Nobel Peace Prize medal to Donald Trump**, the **Nobel Institute** clarified that **prizes cannot be transferred or shared**. **Machado remains the sole official laureate**, and the symbolic gesture does not alter the official status of the award.
- **India-UAE Strategic Defence Partnership**: India and UAE signed **Defence Letter of Intent** creating **Strategic Defence Partnership** focusing on **special operations, cyber security, counterterrorism, and maritime security** in Indian Ocean region during bilateral summit.
- The **world's first legally binding High Seas Treaty** came into effect on January 17, 2026. The agreement **sets global rules to protect oceans beyond national boundaries**. These international waters cover nearly half of the planet. The treaty is seen as a historic step to tackle overfishing, pollution, climate change and threats to deep-sea ecosystems. The High Seas Treaty has **officially entered into force** after ratification by over 60 countries. It establishes global rules to conserve marine life in international waters, also known as the high seas.
- Uganda has concluded a closely watched presidential election with a decisive outcome. Veteran leader **Yoweri Museveni** has been declared the **winner for a seventh term**. However, the results have sparked controversy as the main opposition candidate rejected the outcome, citing irregularities, internet shutdowns, and alleged harassment of polling agents. The election has again put Uganda's democratic process under global scrutiny.
- The **Philippines** is facing a **fresh natural hazard as tropical storm Nokaen** threatens to trigger lahars near Mayon Volcano. The storm is expected to bring heavy rainfall to southern Luzon, raising concerns of muddy volcanic flows in areas already impacted by volcanic unrest. Authorities have urged residents to remain alert and follow safety advisories closely.
- India and the United Arab Emirates have taken a major step to strengthen their economic and strategic ties. During delegation-level talks in New Delhi, both nations agreed to double bilateral trade to 200 billion dollars by 2032. The meeting also resulted in multiple agreements across defence, space, energy, infrastructure and cultural cooperation, reflecting the deepening India-UAE partnership.
- China's population declined by 3 million in 2025. Births fell to a record low despite new child-rearing incentives.
- China is facing an intensifying demographic challenge. New official data shows that China's population declined again in 2025, marking the fourth straight year of contraction, even as the government rolled out financial incentives and policy measures to encourage families to have more children.
- **Abu Dhabi** has been named the **world's safest city for the 10th year in a row** in an international safety ranking released by Numbeo, reaffirming its global reputation for security and quality of life.
- Scientists confirmed that the Sun triggered a **Level-4 solar radiation storm**, the strongest seen since October 2003. The storm caused vivid auroras in Europe and raised alerts for satellites, aviation, astronauts, and power infrastructure.
- **Israel** has taken a significant diplomatic step by agreeing to join US President Donald Trump's Board of **Peace**, a **proposed international body** aimed at overseeing the Gaza ceasefire and post-war reconstruction. The decision, announced by Israeli Prime Minister Benjamin Netanyahu, signals a shift from Israel's earlier reservations and has triggered political and global reactions. Benjamin Netanyahu has confirmed that Israel will join the **Board of Peace proposed** and chaired by Donald Trump. The board is meant to supervise the Gaza ceasefire and future governance arrangements.
- India and Namibia held the **fifth round of Foreign Office Consultations (FOC)** on January 19-20, 2026, where both sides agreed to deepen collaboration in defence and critical minerals along with other key sectors.
- **India has delivered 7.5 tonnes of life-saving cancer medicines to Kabul**, reaffirming its commitment to supporting the people of Afghanistan through humanitarian medical assistance.
- **USA Formally Exits WHO After 78 Years** - United States completed withdrawal from World Health Organization citing pandemic mishandling, with \$130+ million unpaid dues outstanding.
- **India-EU Free Trade Agreement Concluded** - Historic FTA negotiations concluded during 16th India-EU Summit, described as "Mother of All Deals" covering goods, services, and investments.
- **India-EU Signed First-Ever Defence and Security Partnership** - Comprehensive defence partnership signed covering maritime security, cyber cooperation, and defence industrial collaboration.
- **56th World Economic Forum 2026 Concludes in Davos** - WEF annual meeting highlighted India ranked 8th in AI investments (1.2%-1.8% of GDP), with major state investment commitments.

- **Spain's Foreign Minister Visits India for 70th Diplomatic Anniversary** - Spain formally joined Indo-Pacific Oceans Initiative during bilateral visit, upgrading India-Spain ties to Strategic Association.
- **Donald Trump Launches Board of Peace Initiative at Davos** - US President launched Board of Peace initiative for Gaza reconstruction with 35+ countries participating; India took cautious stance.
- **Mozambique's Graca Machel Awarded Indira Gandhi Peace Prize 2025** - Human rights activist recognized for lifetime contributions to education, women's empowerment, and peace with ₹1 crore award.
- **UNEP Report: Global Nature-Negative Spending 30 Times Higher Than Protection** - For every \$1 spent on nature protection, \$30 goes to harmful activities (\$7.3 trillion vs \$220 billion in 2023).

SATELLITE LAUNCHES - NATIONAL

- **EOS-N1 (Anvesha) Earth Observation Satellite - January 12, 2026:** Indian Space Research Organisation (ISRO) launched EOS-N1 hyperspectral Earth observation satellite via PSLV-C62 (64th PSLV flight, 5th PSLV-DL variant) from Sriharikota developed by DRDO for advanced surveillance and strategic monitoring capabilities supporting national security and climate observation.
- **PSLV-C62 Mission - 9th NSIL Commercial Launch:** PSLV-C62 conducted 9th dedicated commercial launch by NewSpace India Limited (NSIL) on January 12, 2026 launching EOS-N1 and 15 co-passenger satellites including AayusSAT, KID, and Brazilian payloads advancing multi-purpose space utilization and commercial space operations.
- **PSLV-C62 Third Stage Anomaly:** PSLV-C62 mission encountered critical anomaly during third stage (PS3) operations necessitating investigation into launch vehicle performance and mission success assessment for Indian space program.
- **AayusSAT - India's First On-Orbit Satellite Refueling Demonstrator:** OrbitAID Aerospace developed AayusSAT as co-passenger on PSLV-C62 advancing satellite servicing and sustainability technologies demonstrating India's emerging capability in space infrastructure services and satellite sustainability.
- **15 Co-Passenger Satellites on PSLV-C62:** Launched alongside EOS-N1 with diverse applications including AI processing in orbit, store-and-forward communications, IoT services, radiation measurement, and agricultural data collection advancing India's multi-purpose space utilization capability.

SATELLITE LAUNCHES - INTERNATIONAL

- **COSMO-SkyMed Second Generation-Flight Model 3 - January 2, 2026:** SpaceX Falcon 9 successfully launched COSMO-SkyMed Second Generation-Flight Model 3 from Vandenberg Space Force Base, California representing first SpaceX mission globally in 2026 for Italian Space Agency and Ministry of Defence with mass ~2,205 kg.
- **COSMO-SkyMed Advanced Imaging Capabilities:** Launched satellite carries advanced Synthetic Aperture Radar sensors and improved imaging capabilities supporting dual-use civilian and defense applications including real-time natural disaster tracking supporting national security, maritime surveillance, and strategic planning 24/7 in all weather conditions.

SPACE RESEARCH & DISCOVERY

- **NASA's Hubble Telescope Discovers Starless Gas Cloud 'Cloud-9':** Hubble Space Telescope discovered rare 'Cloud-9' starless gas cloud located 14 million light-years from Earth near Messier 94 representing fossil from universe's early days published in The Astrophysical Journal Letters.

- **Cloud-9 Composition & Mass:** Reionization-Limited HI Cloud (Cloud-9) containing neutral hydrogen with mass of 1 million solar masses dominated by dark matter with approximately 5 billion solar masses across 4,900 light-year diameter representing unprecedented astronomical discovery of large starless structure.
- **Cloud-9 Discovery Timeline:** Cloud-9 initially discovered in 2023 via China's FAST radio telescope with confirmation through 2025 VLA/GBT observations and 2026 Hubble Space Telescope verification revealing no stars within boundaries of massive gas cloud.
- **Indian Scientists Develop Supercomputer-Powered Mpemba Effect Simulation:** Jawaharlal Nehru Centre for Advanced Scientific Research (JNCASR), Bengaluru under Ministry of Science and Technology published in Communication Physics first-ever supercomputer-powered molecular-level simulation revealing how non-equilibrium thermodynamics, molecular rearrangements, and energy dissipation enable hotter water to freeze faster than colder water.
- **Mpemba Effect Technical Insights:** Simulation offers technical perspective on material relaxation phenomena resulting from abrupt temperature variations advancing understanding of thermodynamic anomalies through supercomputer modeling and molecular dynamics.

SCIENTIFIC RESEARCH & DEVELOPMENT

Weather & Environmental Technology

- **3D-Printed Automatic Weather Stations - Indian Initiative:** Indian Institute of Tropical Meteorology (IITM), Pune under Ministry of Earth Sciences via Make in India initiative developed 3D-printed automatic weather stations for Mission Mausam project providing low-cost, lightweight, quick-to-deploy stations for enhanced weather observation and forecasting.

- **Automatic Weather Stations Deployment:** First batch of 50 automatic weather stations set for February 2026 deployment in Delhi followed by Mumbai, Kolkata, and Chennai with 80 more units planned featuring solar power for urban and remote deployment providing real-time temperature, wind speed, humidity, and rainfall transmission.

Water Purification & Defence Technology

- **DRDO Portable Water Purification System 'SWaDeS':** Defence Laboratory Jodhpur under DRDO developed SeaWater Desalination System (SWaDeS) in manual and engine-driven variants representing critical defence technology for water-scarce operations.
- **SWaDeS Engine-Operated Variant:** Engine-operated variant desalinates seawater with TDS (Total Dissolved Solids) up to 35,000 mg/L to below 500 mg/L supporting 20-25 soldiers within 2-3 minutes setup demonstrating rapid deployment capability for naval and field operations.
- **SWaDeS Manual Unit Capability:** Manual SWaDeS unit supports 10-12 personnel with both variants featuring Chemical, Biological, Radiological, and Nuclear (CBRN) water purification modules making system suitable for naval operations, inland saline lakes, and water-scarce regions.

Biodiversity & Species Discovery

- **Two New Slender-Armed Frog Species Discovered - Arunachal Pradesh:** Indian scientists discovered two new slender-armed frog species from *Leptobrachium* genus in Arunachal Pradesh advancing understanding of Himalayan biodiversity.
- **Soman's Slender Arm Frog (*Leptobrachium somani*):** Discovered at Tiwarigaon in Lower Dibang Valley measuring 55mm and named after late journalist E. Somanath representing new species addition to Indian herpetofauna published in peer-reviewed journal PeerJ.
- **Mechuka Slender Arm Frog (*Leptobrachium mechuka*):** Identified near Mechuka town in Shi Yomi district measuring 60mm and inhabiting evergreen forests and grasslands representing second new species from genus with findings published in PeerJ through University of Delhi collaboration with Harvard Museum of Comparative Zoology.
- **Leptobrachium Genus Global Status:** *Leptobrachium* genus comprises 39 species worldwide with only 4 previously documented in India from family Megophryidae containing 366 recognized species demonstrating India's rich amphibian diversity requiring conservation attention.
- **Brahmaputra River Biogeographic Barrier:** Brahmaputra River acts as major biogeographic barrier with newly discovered species found north of river and other Indian *Leptobrachium* species south of river reflecting distinct species distribution patterns.

- **New Crustacean Genus from Lakshadweep:** Researchers from Cusat discovered 'Indiaphonte bijoyi' new genus and species of microscopic harpacticoid copepod from Kavaratti lagoon in Lakshadweep with semi-cylindrical body and antennae-like appendages published in international journal Zootaxa.
- **Two New Ant Fly Species in India:** Researchers discovered two new rare ant fly species 'Metadon ghorpadei' and 'Metadon reemeri' in Delhi's Northern Ridge forest and Siruvani Hills respectively marking first discovery in over 100 years showing importance of protecting urban forest areas.
- **New Rare Caecilian Species - Maharashtra:** Zoological Survey of India unveiled *Gegeneophis valmiki* new rare caecilian species discovered in Maharashtra's Western Ghats after 10+ year gap in genus discoveries advancing understanding of underground amphibian biodiversity.
- **Austrian Brown Swiss Cow Veronika Uses Tools:** Scientists documented Veronika Austrian brown Swiss cow as first verified tool-using cattle challenging assumptions about cattle intelligence and cognition demonstrating unexpected behavioral complexity in livestock species.

Hypersonic & Advanced Propulsion

- **DRDO Long-Duration Scramjet Engine Test:** DRDO conducted scramjet engine test lasting over 12 minutes validating sustained supersonic combustion at Mach 5+ speeds (6,100 km/h) representing air-breathing technology with active cooling enabling hypersonic flight with high maneuverability and low-altitude capability.
- **Scramjet Technology Development:** Air-breathing scramjet technology indigenously designed by DRDL Hyderabad with support from industry and academia strengthening regional deterrence and hypersonic flight capability for advanced aerospace systems.
- **Scramjet Progressive Testing:** Scramjet testing included 120-second run in January 2025 and 1,000-second endurance test in May 2025 followed by 12-minute validation test scaling up technology gradually demonstrating sustained progress in hypersonic propulsion.
