Affirming people's strength, narrative and purpose reinforce their distinct value. Sharing impact stories, such as how JACT made spaces joyful, moves the purpose deeper. Essentially, building a culture of mattering means leaders must consistently demonstrate to people they are noticed, heard, valued and required.
