Multi Tasking (Non-Technical) Staff, and Havaladar (CBIC & CBN) Examination, 2025 – Declaration of result of Computer Based Examination to shortlist candidates for PET/ PST for the post of Havaladar.

Notice for Multi-Tasking (Non-Technical) Staff, and Havaladar (CBIC & CBN) Examination, 2025 was issued on 26.06.2025. A total of 36,19,834 applications were received. Staff Selection Commission conducted the Computer Based Examination of Multi-Tasking (Non-Technical) Staff and Havaladar (CBIC & CBN) Examination 2025 from 04.02.2026 to 20.02.2026 at various centres across the country. A total number of 8,04,633 candidates appeared in the Computer Based Examination.

2. As the Computer Based Examination was conducted in multiple shifts, marks scored by candidates have been normalized as per the formula published by the Commission's Notice dated 02.06.2025. As per the provision under Para-18.7 notice of the examination, the candidates have been shortlisted for the post of Havaladar (CBIC & CBN), in the ratio of 1:7 (vacancies: candidates) for appearing PET/ PST based on their normalized scores of Session-II in CBE.

3. As per the guidelines mentioned under Para-17.5 of the Notice of Examination, candidates have been considered for selection against the vacancies of only those Post-cum-CCAs for which they have given their preference in their online Application Form.

4. As per the guidelines mentioned under Para-18 of the Notice of Examination, candidates have been shortlisted for PET/ PST based on their Performance in Session-II of CBE. The candidates, who did not qualify in Session-I of CBE were not eligible for evaluation of Session-II. Minimum qualifying marks in Session-I as well as Session-II of Computer Based Examination are as follows:

UR	: 30%
OBC/ EWS	: 25%
All other categories	: 20%

5. The candidates who fail to qualify PET/ PST will not be considered for the post of Havaladar in the final result. However, if such candidates get shortlisted for the post of MTS, their

candidature will remain valid for the post of MTS. First Round of Tentative Allocation result for both the posts i.e. MTS and Havaladar will be declared together at later stage after completion of PET/ PST for the post of Havaladar.

6. Category-wise breakup of candidates provisionally shortlisted for appearing in PET/ PST for the post of Havaladar on the basis of their performance in the CBE is as follows:

7. Category-wise and CCA wise cut-off details in CBE for the post of **Havaladar** are as given in **Annexure-I.**

8. The result of two candidates bearing Roll No. 125270001942 and 125270006713 has been kept withheld on account of suspicious activities.

9. Based on the post-examination analysis, 727 (Seven hundred twenty seven) candidates have been found indulging in malpractices in the CBE as per Para 20 of the Notice of Examination and the Commission's Notice dated 10.09.2025 regarding warning and Advisory against Malpractices in Computer Based Examinations (CBE). Accordingly, the results of 727 candidates have not been processed due to their having indulged in malpractices in the Examination as per **List-II**. Aggrieved candidates are at liberty to represent their case before the Regional Office concerned, Commission.

10. Result of 169 candidates has been debarred by the respective Regional Office due to various reasons. Roll Number of these 169 candidates is as per **List-III**.

11. As per the tie resolution criteria mentioned in the Para-19 of the Notice of Examination, in cases where more than one candidate secured equal aggregate marks in Session-II, tie has been resolved by applying the following methods one after another in the given order till the tie is resolved:

- Normalized marks in General Awareness of Session-II.
- Total normalized marks in Session-I.
- Date of birth i.e. the candidate older in age gets preference.
- Alphabetical order of the names.

12. The schedule of PET/PST for the posts of Havaladar will be available on the website of the

Commission in due course.

13. Representations received from the candidates with regard to the Answer Keys have been carefully examined and the Answer Keys have been modified wherever necessary. The final Answer Keys have been used for evaluation.

14. Final Answer Keys and marks of the qualified/non-qualified candidates will be uploaded on the website of the Commission after declaration of the final result of the examination.
